- Approving the resource consent provides the OPTION to develop Te Ara Tipuna. Rejecting an option that has the potential to provide for economic, social and cultural development as well as the potential to support environmental restoration, before that option has been fully considered, and in the absence of comparable alternatives, would be short sighted. We are expecting risks and community concerns will be thoroughly addressed through the next phase

I oppose all parts of the application that impacts my whenua at 107 Orete Point Road, Waihau Bay.

The reasons for making my submission are (briefly describe the reasons for your views:

This submission is in opposition to all parts of the application that impact the property known as

Te Koi o Orete at 107 Orete Point Road, Waihau Bay.

Any consent given would impact, in a negative way, my land and potential income, as well as my family's privacy, well being and security. The proposed walk way is far too close to my residence and runs between two of my properties. I currently enjoy permitted access from my residence (Orete P Block) across the proposed area (Orete Q) to my other block (Orete R). Any construction on the proposed area between my blocks would cut off, impede or limit my access.

My grandfather, Pene George Callaghan decided to stop public access onto his land 50 years ago after ongoing problems with damage to fencing, loss of live stock and constant littering from the public. Since then we have enjoyed a peaceful life style and lower maintenance costs. This proposal will reverse everything we have gained in that 50 years.

My father, Perenu Kaingakau Callaghan followed that kaupapa and I have done the same. We simply do not allow people on our land who will not respect it. A walkway will open up our land for public use and abuse.

There have also been human skeletal remains found in part of the area proposed so may be an urupa. The remains were sent for examination at Te Papa and have been documented.

I fear that a walk way of such magnitude would become an alternative route for unruly and criminal elements to thrive and evade authorities. This would be a great opportunity for motorcycle riders with a disregard for rules, to take advantage of the situation.

If local council decides at any time to take over maintenance, it would impact my rating charge.

I am writing to formally object to the above-mentioned

resource consent application submitted by Te Ara Tipuna

Charitable Trust (LU-2020-112074) to construct, operate, and

maintain a recreational pathway, â€~Te Ara Tipuna,' around

TairÄ whiti from Gisborne to ÅŒpÅ tiki. My objection is based on the following key points:

1. Legal Rights of the Applicant

I contend that Te Ara Tipuna Charitable Trust, as non-owners of our whenua, and does not have the legal right to submit a resource consent application to construct, operate, and maintain a recreational pathway on our land without consulting us and obtaining our consent.

Under New Zealand law, the ability for a non-owner to apply for resource consent to build on MÄ ori land is subject to specific legal requirements, primarily governed by the Resource Management Act 1991 (RMA) and Te Ture Whenua MÄ ori Act 1993.

Authority to Apply

A non-owner cannot legally apply for resource consent for a project on MÄ ori land without the explicit approval or authorization of the landowners or governing trustees. Any proposed development must have the consent of those with decision-making authority over the land.

I am exercising my legal rights under the RMA and Te Ture

Whenua MÄ ori Act 1993 to declare this application invalid. We

assert that this application is unlawful as we were not

consulted, nor did we grant consent for this project. Our

decision-making authority over our whenua has been

disregarded, as we suspect is the case for many other

landowners affected by this project.

While we recognize that legal redress is available to us, this is an

unnecessary and unfair burden given that the RMA is designed

to protect landowners and ensure their sovereignty (tino

rangatiratanga) over their whenua.

The RMA clearly emphasizes the need for consultation with

affected parties, including MÄ ori landowners, in matters

involving MÄ ori land. The failure to appropriately consult us as

landowners undermines the integrity of this application and

exposes it to legal challenge.

We request that this application be reconsidered and rejected

Additionally, my roles as a Trustee for one of my marae, a Trustee for our hapu collective, and the Board Chair for Te Kura Kaupapa Maori o Te Waiu o Ngati Porou further fuel my resolute support for this kaupapa. Personally, the intersections and connections across each of these roles are clear, with education being the central theme.

I am privileged to have been raised by my grandparents from birth, within a resourceful, resilient, and rich community in terms of our 'Rangitukiatanga' (cultural identity). Growing up, I was surrounded by a proud and prolific sense of identity, where everyone spoke Maori and upheld strong cultural values. They knew who they were, they knew where they were from and they knew who they came from. This upbringing instilled in me a profound appreciation for our heritage and the importance of preserving it for future generations.

Fast forward 50 years or so, and today we see a different community. There has been a noticeable decline in our resourcefulness, resilience, and cultural strength. This decline has prompted us to take action to restore and revitalise our language and culture. We are working towards forming stronger connections within and across our whanau and hapu. I consider that this project provides the perfect platform for the restoration and revitalisation of our future. It encourages us to use our space to bring life to our uniquenessâ€"our history, genealogy, stories, practices, and sites of significanceâ&"and to retain these for our current and future generations.

Submission on behalf of Te WhÄ nau a Rangi-i-Runga and Te WhÄ nau a Kahurautao

Mai Kahu ki Te Rangi Trust

Mai Kahu ki Te Rangi Trust was established in 2023 as part of the Treaty settlement negotiations between the Crown and Te WhA nau a Apanui. As part of the final treaty packageâ€"ratified by both the Crown and Te WhÄ nau a Apanui and approved by the whole tribeâE"the Trust will receive assets from the settlement, including reserve lands within our traditional boundaries. The Trust is also mandated to represent the two hapū on matters relating to resource consent applications and activities that occur within our rohe. We believe that this application will have a negative impact on the reserves lands being returned to us and will also have negative impact on our beneficiaries who own extensive land within our rohe

Te WhÄ nau a Kahurautao and Te WhÄ nau a Rangi-i-Runga hold exclusive mana whenua status between Te Tapapa a Piha and Te Iringa a Pararaki.

The proposed route of Te Ara Tipuna is set to pass through our rohe, and as such, we consider ourselves to be affected parties to this application. While Mai Kahu ki Te Rangi Trust recognizes the sentiment behind this consent and supports the general aspiration of the applicant to create economic opportunities for the iwi and communities of Te TairÄ whiti, the Trust cannot support this application in its current form. The application lacks detail, is based on naive assumptions, overstates supposed positive effects, demonstrates poor consultation and engagement, and has negative impacts on cultural, environmental, and archaeological values. Furthermore, there has been little or no attempt to seek landowner approvals from MÄ ori landowners within our rohe.

To be clear, the Trust is opposed only to the aspects of this application that pass through the traditional rohe of Te Whanau a Kahurautao. Unlike the applicant we do assume to speak for other hapū or iwi who may support the application.

The Trust encourages the applicant to withdraw or press pause on their application until more appropriate consultation can be undertaken, and a more detailed and thorough approach is developed.

Opposition is based on the following:

General Approach and Assumptions

The application acknowledges the extensive geographical scale of the proposed activity, spanning over 500 km. However, the applicant and their associated technical experts have adopted a generalised approach, relying on broad, sweeping statements and assumptions. The conclusions that the effects are less than minor or can be managed through conditions seem to be based largely on desktop analysis, without sufficient fieldwork to validate these assumptions.

Cultural Values Assessment (CVA)

The Cultural Values Assessment (CVA) is vague and does not provide a meaningful understanding of the cultural values at the site. Instead, it suggests that further CVAs will be required. This is intellectually lazy and offers us, the hapū, no certainty that our values will be protected through this application.

The "Passport†Process

The applicant places significant emphasis on a "passport" process to ensure that users of Te Ara Tipuna follow rules, tikanga, and protect wahi tapu. However, there is no evidence that such a scheme will work. This is further





reinforced by the fact that no other recreational track providersâ€"including the Department of Conservation, local and regional councils, or private landownersâ€"use a "passport" as a means of protecting against environmental, ecological, or cultural impacts.

4. Poor Consultation Process

The consultation process has been inadequate. Only one meeting was held within the rohe of Te WhÄ nau a Apanui, and no hui were held within the rohe of Te WhÄ nau a Rangi-i-Runga or Te WhÄ nau a Kahurautao. There has been no attempt to engage MÄ ori landowners, and at face value, it seems that no Landowner Approval has been sought from anyone.

5. Overstated positive impacts.

The application speaks of positive cultural effects and that we somehow need the track to retain our cultural knowledge. Our hapū already retain our cultural knowledge through traditional means and do not require the help of the applicant. The applications discusses ecnomic opportunities for the hapū but with no analysis of what the economic opportunities might be.

Insufficient information on required assets or how these assets will be maintained.

The applicant discusses a minimal approach to infrastructure explaining that 90% of the route will not require any actual track or assets. again very little site visits have been undertaken as part of this application and we believe that this stance is naà ve. There is no projection of numbers of track users and what the effects might be. If there is a significant number of people in there 1000s walking the track then this would cause insurmountable impact on the area. This approach is not supported by the NZ track standards and shows the lack of understanding the applicant has regarding such experiences.

Furthermore there is no maintenance plan for any of the assets and it seems that the applicant intends to leave toilets, track infrastructure, bridge clip ons and other pieces of infrastructure in situ degrade over time and become yet another burdon on our hapu

Finally there is not one toilet proposed throughout our entire rohe meaning that people will end up defecating on private land and causing negative impacts on our health, our environment and on our cultural landscape

7. The application puts landowner at risk of breaching Health and Safety Legislation.

If a route does pass through private land â&" this will mean that landowners will become a PCBU and be accountable under the Health and Safety at Work act. This again places further burdon on land owners.

We wish for our submission to be heard where we will expand on the points raised above.

Tēnā koe,

I write this letter to express my strong opposition to the proposed Te Ara Tipuna Trail as a mokopuna of the whenua directly affected by this project. My connection to this land runs deep, and I am gravely concerned about the lack of consultation, the cultural and environmental risks, and the broader impact on our people and future generations.

It is deeply disappointing that tangata whenua have not been properly consulted on this matter, in direct contradiction to the principles of Te Tiriti o Waitangi and the requirements of the Resource Management Act (RMA). The Resource Management Act 1991 outlines specific provisions that emphasize the importance of consulting with mana whenua:

- Section 6(e): This section identifies "the relationship of Māori and their culture and traditions with their ancestral lands, water, sites, wāhi tapu, and other taonga" as a matter of national importance. Decision-makers are required to recognize and provide for this relationship, which necessitates meaningful engagement with mana whenua.
- **Section 7(a)**: This clause obliges all persons exercising functions under the RMA to "have particular regard to kaitiakitanga," referring to the guardianship and stewardship by Māori over natural and physical resources. Engaging with mana whenua is essential to understand and respect their role as kaitiaki.
- **Section 8**: This section mandates that decision-makers "take into account the principles of the Treaty of Waitangi (Te Tiriti o Waitangi)." One of the core principles is partnership, which includes the duty to consult with Māori to ensure their interests are considered in resource management decisions.

As descendants of this whenua, our voices deserve to be heard and respected. The RMA mandates meaningful engagement with tangata whenua in matters that impact our whenua, resources, and heritage. Anything that affects our land and people must adhere to these legal and moral obligations by involving those who hold the historical and cultural guardianship of these places in a genuine and substantive way.

The proposed trail fails to align with the priorities and aspirations of our whānau and hapū. Instead, it imposes an external vision by Runanga members who have not supported our hapū, our whenua, disregarding the potential disruptions to our way of life. What economic and social benefits will this do for our Rohe? Who will monitor the use of the trail? Along with the long-term consequences of diminished autonomy over our ancestral land and the erosion of our role as kaitiaki?

As a mokopuna of this whenua, I assert the need for a transparent and inclusive dialogue around this proposal. It is essential that we, as tangata whenua, are involved in decisions that will impact our future, and given the opportunity to voice our concerns. Without such engagement, the project loses its legitimacy and disregards the core principles of Te Tiriti o Waitangi partnership and respect for the whenua.

Our people must be at the heart of this conversation, not sidelined in decisions that profoundly impact us. I request the opportunity to engage further on this matter and to ensure that our voices are heard and considered.
